If not already done so, the undertaker will furnish you with a copy of the further information. Also, please find enclosed a copy on CD.

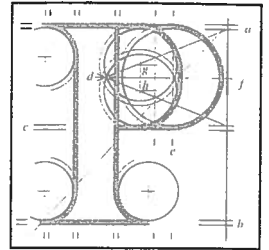

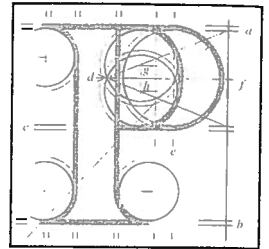
